2. BUYER SENDS APPOINTMENT LETTER TO MEET TTM agenda bellow:
  - Buyer show live POF via zoom meeting
  - Seller show Fresh SGS report in the SGS Office (less than 48 hours old, 7 pages)
  - Seller issue:
    - A. Seller shows Q88 (from logistic company)
    - B. Injection report.
    - C. Certificate of Origin. (COO)
    - D. Authorization to sell and collect (ATSC).
    - E. Tank Storage Receipt (TSR).
    - F. Authority to Verify (ATV) – Physical Inspection
    - G. Dip Test Authorization (UDTA) + Access Permit (3 person)
    - H. NCNDA/IMFPA is signed.
3. Buyer has optional Dip Test inspection on the product in Supplier/ Seller storage tanks via SGS at Buyer's expense.
4. Upon successful dip test inspection (if necessary), Buyer makes payment for the total product value by MT 103/TT upon injection of completion to ULTRA DYNAMICS S.A. DE C.V. and ULTRA DYNAMICS S.A. DE C.V. IMMEDIATELY PAYS THE TITLE HOLDER and all commissions as per executed NCNDA/IMFPA for this transaction within 72 hours of receipt of payment from Buyer.
5. Seller immediately transfers the title of product ownership to Buyer with all export documents.
6. All costs associated with the tank extensions, TSR, TTVIA, CPA, etc.. in charge to the buyer will be programmed and paid during the same meeting.

## TTO / TITLE (TANK) TAKE OVER / POSSIBLE TTV / TTT

- 1.- Buyer issues ICPO for verification and international passport (CIS) to seller.
- 2.- Seller issues Commercial Invoice (CI) for the Quantity of product,

  - b) Certificate of Origin (CO)
  - c) Unconditional Dip Test Authorization (UDTA)
  - d) Injection Report
- 5.- Buyer conducts inspection by SGS on buyer s expenses on tanks or vessel. (if necessary)
- 6.- Buyer pays for 1 to 10 days tank extension or programs transfer same day to their tanks or vessel, immediately after title is transferred to buyer.
- 7.- Buyer makes payment of the product via MT103 and Seller transfers Title.
- 8.- Second & succeeding shipments continue.
