We are supplying to government administrations, and unfortunately we can do business with sellers who accept our determined and approved receiver procedures.

Perhaps your procedures may be very safe, but we are forbidden to buy fuel other than our procedures.

We sell these fuels to the energy ministries of international governments. In other words, they purchase from us through a tender. According to the purchased tender, 20 different groups will come every month, with 10 of them arriving at the ports in the morning and the other 10 in the afternoon. The managers representing these groups will see the fuels in the tank farm with their own eyes and will conduct physical inspections every month. For 120 months, 20 groups will inspect the fuels within 10 days each month, both in the morning and afternoon. Now, what I need from you is to recommend the procedure that allows us to conduct these visits according to the protocols. These groups will come to the ports for verification and will report the existence of the fuels to their respective energy ministries and to me. These groups should not encounter any problems at the port and terminal entrances. They should not face any secret payments or expenses in any way. Their only task is to see the fuels and provide a verification report.

After this verification is completed, the same groups will organize their SGS teams and will return to the port for a dip test. So, the first phase is the physical verification of the fuels, and the second phase is to conduct a dip test on the fuels. They will not incur any extra costs or payments for these two processes.

What you need to remember here is that our technical team must not encounter any problems during the physical verification and SGS stages. There should be no obstacles whatsoever. They must provide unconditional and unlimited access.

The part that concerns me is that the original POP documents must be notarized and sent to me via DHL to our address. They must also send the same documents only to my email address. When we receive the original documents, I will issue a bank payment order, and the funds will be transferred to the seller's refinery bank accounts via MT 103 after the documents are regularly delivered to us.

We accept your invoice, but we can always pay your payments within 20 working days after the test is completed. There should be zero obstacles and zero conditions between us and the fuel.

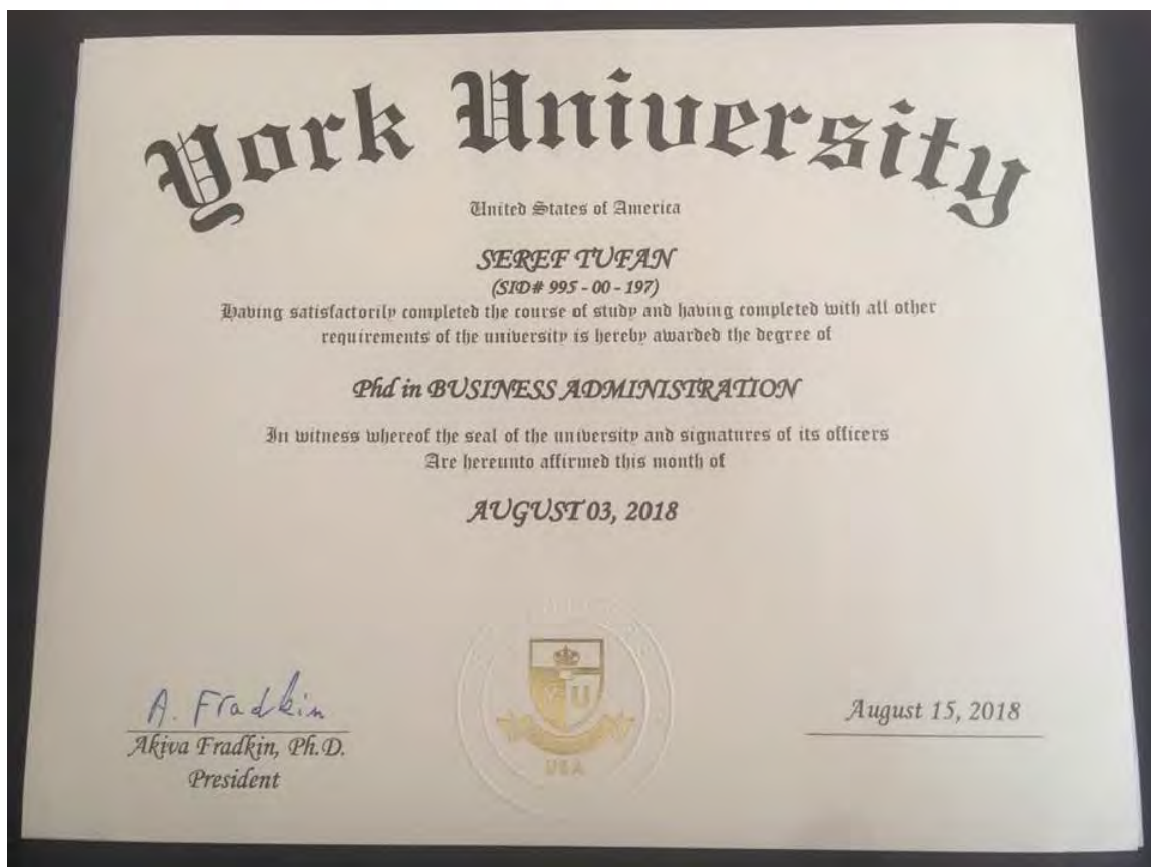

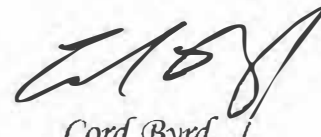
