- •ATV Authority to verify the existence of product from the storage company.
- 4. Buyer contact Refinery to request for DIP TEST AUTHORIZATION PASS to allow buyer vessel to go into terminal and conduct Dip Test, CIQ Inspection & SGS After you have conducted DIP test in seller tank Before issuing Q88
- 5. Upon receiving the Clearance certificate issued by Tank farm agent to buyer, buyer sends a copy to Seller to effect the transfer of Allocation Title Ownership to Buyer's name.
- 6.Buyer after successful Q &Q Dip test on the product, buyer makes the payment for the total value of product injected into the tanks through the means of MTI03 -TT.
- 7. Upon seller receives the payment for the product from the buyer, seller issues to buyer the Title ownership of the product and all exporting document of the Product
