1. Buyer Issue ICPO, Company Registration certificate and Buyer international passport copy.
2. Seller Issue Draft Contract (SPA) Sales and Purchase Agreement for Both Parties Final Endorsement.
3. Seller Issue to Buyer:
 - (a) CONFIRMATION / COMMITMENT LETTER TO SUPPLY,
 - (b) TANK RECEIPT
 - (c) CERTIFICATE OF ORIGIN OF THE PRODUCT,
 - (d) STATEMENT OF AVAILABILITY OF THE PRODUCT,
 - (e) PRODUCT PASSPORT

4. After successfully verifying the above documents Within 48 hours the buyer contacts the seller tank and extends the seller tank to enable the seller to start injecting the product into a ship that will transport the product to the port designated by the buyer. **The buyer will pay the 2-day tank extension payment every month for 36 months on the same date as the fuel bill. The buyer and seller have agreed on this issue. It will be specified in SPA. The buyer will not be directed to pay anywhere until the updated bottom test reports are completed at the discharge port of the fuels. No hidden charges or mandatory charges will be requested.**

5. Upon successful confirmation, Seller commenced loading of the products into Buyer's nominated tank or vessel and shipment commences. And seller sends to buyer all the full POP documents below. (Seller also endorses NCNDA/IMFPA signed by all parties and lodge to their bank respectively.

6. After successful Q&Q by buyer at the discharge port, buyer pays seller through MT103 - **After the ship reaches the discharge port, Q/Q will be given to the seller after the physical visit of the buyer and the bottom test / SGS.**

7. After successful confirmation of buyer's payment to seller nominated bank account, seller pays Intermediaries commissions within 72 hours of receiving

of receiving buyer's payment for the product.

8. If either party violates the obligations assigned to him in this agreement, then that party has the right, without prejudice to other legal remedies available to him, to consider such failure as non-compliance with this agreement or unilaterally suspend his obligations. Such errors must be corrected and in both cases, the damage and prejudice caused by non-compliance can be compensated. If the buyer does not receive the product or pay for the product or the order is not delivered by the seller according to the delivery schedule or the seller does not pay the intermediary commission for this transaction, then the party who does not carry out its obligations will be subject to a fine in the amount of the TOTAL CONTRACT PRICE in USD per DELIVERY, and this provision is valid as long as CONTRACTS and ROLL EXTENSION.
